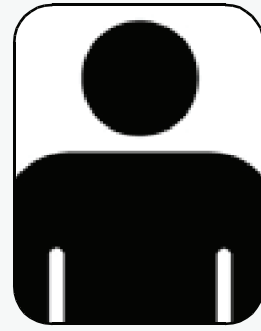

In consideration of South Pacific Pictures Limited (the "Producer") agreeing to make arrangements for the filming and recording of my contribution to the Programme, I hereby consent to the filming and recording of such contribution subject to the terms and conditions specified below:

TERMS AND CONDITIONS

1. I am 16 (sixteen) years of age or older and less than 31 (thirty-one) years of age on 17 April 2006 and will supply a copy of my birth certificate, drivers licence or passport to confirm this. I am a New Zealand citizen or hold a New Zealand Residence Permit.

2. I will abide by the rules, regulations, terms and conditions (the "Rules") of "NZ Idol", including any interview, auditioning process, competition, event, activity, promotion or publicity relating to it (the "Programme") as devised from time to time by the Producer and will accept the decision of the Producer as final and I hereby acknowledge that the interests of the Programme shall override those of any contributor, including myself. I acknowledge that the Rules are available for me to review on the audition day and at tvnz.co.nz, keyword: nz idol.

3. I have not and will not enter into any commercial or other sponsorship agreement or arrangement with any person, firm or company in respect of my appearance in the Programme. I confirm that as at the date of signing this agreement and for the duration of the competition, I am not party to and will not be party to any contract or arrangement in respect of my musical or performing abilities which might breach the Rules or prevent my full and free participation in the competition.

4. I acknowledge that there is no obligation on the part of the Producer to record or broadcast any Programme in which I appear or any part of my Contributions to the Programme.

5. With full title guarantee I hereby assign irrevocably to the Producer (including present assignment of future copyright) the entire copyright and all other rights of whatsoever nature in and to my audition and contribution to the Programme including but not limited to any literary, dramatic, musical or artistic work (within the meaning of the Copyright Act 1994 (the "Act")) incorporated therein in which I own copyright (the "Contributions") such that the Producer shall be entitled to use and exploit and license others to use and exploit such Contributions by all means and in all media and formats whether now known or hereafter invented throughout the universe for the full period of copyright including any extensions and renewals thereto and thereafter insofar as is possible in perpetuity. Furthermore, I also waive all moral rights that I have in relation to the products of my Services in relation to the Programme, including without limitation full waiver of the rights specified in sections 94 and 98 of the Act ("Moral Rights") pursuant to section 107 of the Act.

6. Without limiting the forgoing in any way, the Producer shall be entitled to: (a) alter, adapt or make additions to or deletions from the Programme (and my appearance thereon) at its discretion; (b) make and exploit and to authorise the making and exploitation of any recording or fixation of my appearance separately from or in conjunction with the Programme throughout the universe in perpetuity in all media whether now known or hereafter invented; (c) dub my voice in any language; and (d) include my name, likeness, voice, biographical details (which includes, without limitation, any personal information as defined in the Privacy Act 1993 or otherwise ("Personal Information")), photographs of me and recordings of interviews with me separately from or in conjunction with the Programme in all media and formats throughout the universe including but not by way of limitation in advertising, publicity

and exploitation material. For the avoidance of doubt, I irrevocably consent to the Producer (and persons authorised by the Producer) transferring Personal Information about me overseas to related body corporates and third parties associated with the Programme and to use the Personal Information in accordance with the provisions in this sub-clause.

7. I acknowledge and agree that the Producer's labour and expense in making arrangements for the filming and recording of the Contributions and the opportunity provided to me to potentially appear in or in association with the Programme (the "Benefits") include sufficient and adequate consideration for the use and exploitation of the Contributions and the Programme (including without limitation my appearance in any and all episodes of the Programme) by any means and media, anywhere in the universe and I waive any right and/or entitlement to any equitable relief, remuneration or other payment howsoever arising in connection with such use or exploitation. I further acknowledge and agree that the Benefits also include full and final consideration for my attendance at any and all activities as required by the Producer in connection with the Programme.

8. I acknowledge that no repeat fees will be payable to me in respect of any subsequent rebroadcast or retransmission or any other use by the Producer (or any assignees or licensees) of the Programme or any part thereof.

9. The Producer shall not be liable to me or my legal representative for any loss or damage or injury to me or my property caused by or suffered during or in connection with my taking part in the Programme.

10. I agree not to disclose to any third party (other than my professional advisors) without prior written consent from the Producer any information relating to the Programme, my appearance, any of the production team, any participants in the Programme, the broadcaster nor any other information which may come to my attention relating to the affairs of the Producer (or any associated company) which may come to my knowledge during or in connection with my participation in the Programme.

11. If I am contacted by the media I agree to refer them to the Programme's Producer.

12. I hereby agree that I will truthfully and accurately complete all forms and that the answers and information I will supply will be in no way misleading. I furthermore acknowledge that the Producer reserves the right exercisable at any time at its sole discretion to disqualify me from the competition or auditioning process should I at any stage supply untruthful, inaccurate or misleading personal details and information, break the Rules or otherwise be in breach of the terms contained herein.

13. The Producer may assign my services and all other rights in my Contributions to and participation in the Programme to any third party.

14. If any Clause or part of the agreement in this release shall for any reason be properly adjudged by any court or other legal and/or competent authority to be invalid, illegal or unenforceable in any respect the legality and enforceability of the remaining provisions contained herein shall not in any way be affected or impaired.

15. The Courts of New Zealand shall have sole jurisdiction in relation to the terms and conditions of the agreement contained in this release, which shall be interpreted according to the laws of New Zealand.
