- * Applicants must be available to attend auditions in Auckland on dates to be advised (approximately two days).
- * Applicants must be available for filming in Auckland on dates to be advised (maximum one week).
- * Applicants must be available for filming in their home-town (approximately one day).
- * Applicants must be available for vocal coaching and wardrobe/make-up appointments.
- * You must be willing to undergo any further vetting procedures required.
- * Employees of Imagination TV and TVNZ and their immediate families are not eligible to enter.

Returns Policy:

We will not return any applications or any materials submitted such as documents, photos, or videos. Please do not send original copies of important documents or materials that are unable to be replaced.

Acknowledgement & Selection:

- * Applications that provide an email address will receive emailed confirmation that their application has been received.
- * Short listed or successful applicants will be contacted to discuss the next steps in the selection process. Because of the large number of applications we receive, we may be unable to advise you if your application is unsuccessful.

Successful Applicants:
